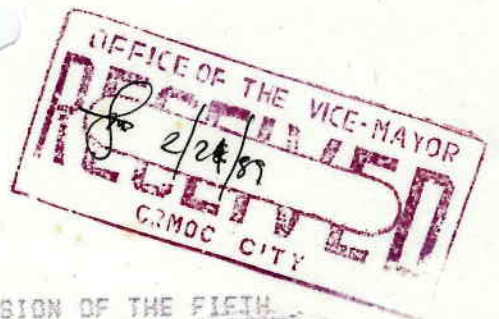

RESOLUTION NO. 29

A RESOLUTION REQUESTING THE CITY FISCAL OF ORMOC CITY TO ANSWER, FOR AND IN BEHALF OF THE SANGGUNIANG PANLUNGSOD NG ORMOC, THE CIVIL CASE: SPECIAL CIVIL ACTION NO. 2827-8 FILED BY THE RANCO CORPORATION (PETITIONER) AGAINST THE SANGGUNIANG PANLUNGSOD NG ORMOC, ET. AL., (RESPONDENTS), AND, FURTHER REQUESTING THE CITY FISCAL OF ORMOC CITY TO APPEAR AND ANSWER, FOR AND IN BEHALF OF THE SANGGUNIANG PANLUNGSOD NG ORMOC, IN SAID LITIGATION.

WHEREAS, the Fifth Sangguniang Panlungsod ng Ormoc in line with its earnest and sincere desire to curb gambling, to get rid of the pernicious effects thereof and to defend the people's general welfare, has enacted Resolution-Ordinance No. 16 on December 22, 1988, banning the Small Town Lottery, or STL, in its operation in Ormoc City;

WHEREAS, the RANCO Corporation, represented by Robert Juson, has questioned the validity of the aforesaid Resolution-Ordinance and has filed a Special Civil Action No. 2827-8 before the Regional Trial Court, Region VIII, Branch 12, Ormoc City, against the Sangguniang Panlungsod ng Ormoc, et. al., as respondents;

WHEREAS, the City Government in the meantime, has no Legal Officer to handle or take charge court litigations;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, jointly seconded by mga Kagawad Eufrocino C. Codilla, Jr. and Gregorio A. Yrastorza, Jr., be it

RESOLVED, to earnestly request the City Fiscal of Ormoc City to answer, for and in behalf of the Sangguniang Panlungsod ng Ormoc, the civil case: Special Civil Action No. 2827-8 filed by the RANCO Corporation (Petitioner) against the Sangguniang Panlungsod ng Ormoc, et. al., (Respondents), and, to further request the said Honorable City Fiscal to appear and answer, for and in behalf of the Sangguniang Panlungsod ng Ormoc, in said litigation;
