RESOLUTION NO. 33

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE THE 1988 EXPENDITURES INCURRED ON NEWSPAPERS SUBSCRIPTION IN THE AMOUNT OF P136.50 AGAINST CURRENT APPROPRIATION FOR SUPPLIES AND MATERIALS OF THE OFFICE OF THE REGISTER OF DEEDS.

WHEREAS, this august Body is in receipt of a letter dated February 3, 1989 from Atty. Antero P. Suarez, Register of Deeds, this city, requesting for an authority to transfer an account payable re: expenses incurred on newspapers subscription for the months of November - December, 1988, in the amount of One Hundred Thirty Six Pesos & 50/100, (P136.50), to current appropriation of said Office due to budget deficit, as alleged, in said Office for the year 1988;

WHEREAS, the City Budget Officer has recommended that authority be granted the City Treasurer to charge the aforesaid 1988 expenditures for newspapers subscription of the Office of the Register of Deeds against its current appropriation for supplies and materials;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, duly seconded by Kagawad Romeo M. Hermosilla; be it

RESOLVED, to authorize the City Treasurer to charge the 1988 expenditures on newspapers subscription incurred by the Office of the Register of Deeds amounting to ONE HUNDRED THIRTY SIX PESOS & 50/100 (P136.50), against Current Appropriation for Supplies and Materials of said Office;
