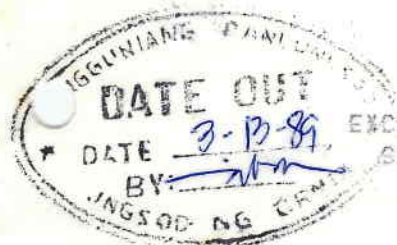

RESOLUTION NO. 35

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO EXECUTE A DEED OF DONATION IN FAVOR OF THE POSTAL SERVICES OFFICE, DEPARTMENT OF TRANSPORTATION AND COMMUNICATION, COVERING AN AREA OF 1,000 SQUARE METERS OUT OF LOT NO. 2-B AT THE GOVERNMENT CENTER SITE ADJACENT A PROPOSED L.T.C. BUILDING OR LOT NO. 2-A, FOR THE CONSTRUCTION OF A POST OFFICE BUILDING, WITH A PROVISION THAT THE LOT BE RETURNED TO THE CITY GOVERNMENT IF NO LONGER NEEDED BY THE SAID DEPARTMENT.

WHEREAS, Her Honor, the City Mayor, has forwarded to this august Body a communication from the Postal Services Office, Department of Transportation and Communication, the same communication to read as follows:

The Honorable Mayor:

This has reference with your letter dated 30 January 1989 regarding the site of the proposed Ormog City Post Office building of your locality.

(RES. NO. 35)

We had an ocular inspection on the proposed original location for the said project yesterday February 25, 1989, but according to your Secretary the said lot is reserved for the proposed Ormoc City Medical Center.

In this connection, we would like to request from your Office that the proposed Ormoc City Post Office lot be located adjacent to the L.T.C. building and parallel to the proposed road with a minimum front distance of 24.0 M and at least with an area of 1000 sq. m. since it is still vacant as shown on the attached sketch plan and its high elevation a very good site for a Post Office building.

Our proposal is to lessen the amount of expenses on the site development plan which consume a little volume of filling materials compared to the proposed plan in front of IGLESIA NI CRISTO site which is almost 1.50 M. depth to be filled. By this volume of filling materials, the proposed Ormoc City Post Office fund will be little if the proposed Post Office lot will not be changed.

On this behalf, I humbly request for your benevolent consideration to approve the above request for economy wise and cost reduction reason in financing the proposed Ormoc City Post Office building.

WHEREAS, this august Body finds the request most worthy of consideration and that there is a lot available for the construction of the Post Office Building at Lot No. 2-B covering an area of 1,000 square meters, adjacent to the proposed L.T.C. Building at Government Center, Ormoc City;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, duly seconded by mga Kagawad Gregorio A. Yrastorza, Jr. and Rodolfo L. Rivilla, Jr.; be it

RESOLVED, to approve the request of the Regional Director, Postal Services Office, Department of Transportation and Communication, Region VIII, Tacloban, and do, as this Body does, authorize the Honorable City Mayor to execute a deed of donation in favor of the Postal Services Office, covering an area of 1,000 square meters out of Lot No. 2-B which is adjacent to the site of a proposed L.T.C. building at Government Center, Ormoc City, said lot to be made available for the construction of a Post Office building; PROVIDED, HOWEVER, that should the Postal Services Office, Department of Transportation and Communication, no longer need or use such lot, the same shall be returned immediately to the Government of Ormoc City;

ENACTED, March 9, 1989.

RESOLVED, FURTHER, to furnish a copy of this resolution each to the Postmaster General, Manila; the Regional Director, Postal Services Office, Department of Transportation and Communication, Region VIII, Tacloban; the Honorable City Mayor, the City Engineer, the City Postmaster, - all in Ormoc City;
