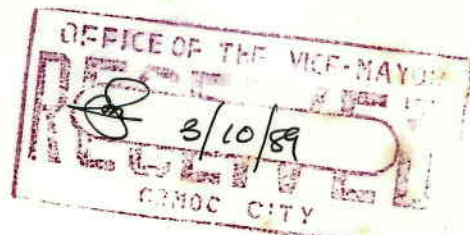
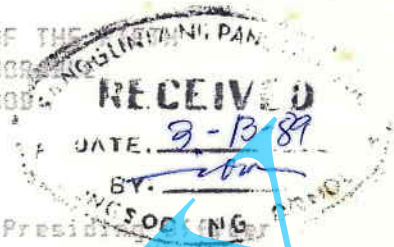

RESOLUTION NO. 37

A RESOLUTION APPROVING AND CONFIRMING THE AUTHORITY OF THE HONORABLE
CITY MAYOR OF HER REQUEST WITH THE PHILIPPINE PORTS AUTHORITY,
(P.P.A.), FOR THE ISSUANCE OF A PERMIT TO OPERATE AND ADMINISTER
THE ORMOG CITY PORT

WHEREAS, this august Body is in receipt of a communication dated
March 7, 1989 from the Honorable City Mayor, this city, requesting for
the passage of a resolution approving and confirming the authority of
the City Mayor relative her written request with the Philippine Ports
Authority for the issuance of a permit to operate and administer the
Ormog City Port, invoking, among others, that, as classified by the
Philippine Ports Authority, the Ormog City Port is a Municipal Port and
as such the City Government is empowered to operate and administer the
same if it so pleases, taking into view that the PPA permit of the
present operator, the New Eagle Arrastre Service, Inc., had long expired
on August 31, 1987 and has not been renewed;

WHEREAS, the aforementioned move of the City Chief Executive is in
keeping with the Mayor's Program of Government which is generally
outlined for the ultimate welfare of its constituents, considering that
the populace would be benefited out of the immense possibility of
generating revenues in the operation and administration of the Ormog
City Port;

WHEREAS, Her Honor, the City Mayor, is herself, an Ormocanon and,
has in her hands and mind an effort to give Ormog City a facelifting
every now and then towards improvement and progress;

WHEREAS, this august Body adheres to the Mayor's Program of
Government being ultimately premised with deep concern to the upliftment
of Ormog City and for the benefit of its populace;

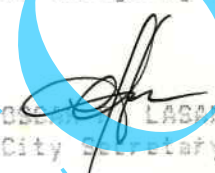

ENACTED, March 9, 1989.

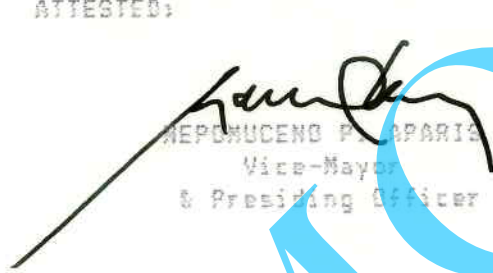
