A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE THE AMOUNT OF P4,155.00, PAYMENTS FOR TELEPHONE SERVICES FOR THE MONTH OF DECEMBER, 1988, AGAINST CURRENT APPROPRIATION FOR COMMUNICATION SERVICES OF THE CITY TREASURER'S OFFICE.

WHEREAS, Voucher No. 258 dated January 19, 1988 carrying an amount of Four Thousand One Hundred Fifty Five Pesos, (P4,155.00), to payments for telephone services on telephone connection of the different Offices, as therein enumerated, of the City Government for the month of December, 1988, is presented for consideration;

WHEREAS, the City Budget Officer favorably recommends and has requested for the passage of a resolution to authorize the City Treasurer to charge the aforesaid amount of P4,155.00 against Current Appropriation for Communication Services of the City Treasurer's Office;

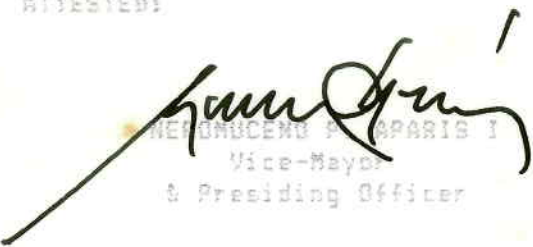
