A RESOLUTION INDORSING WITH FULL SUPPORT RESOLUTION NO. 82 SERIES OF 1989 OF THE CITY COUNCIL OF DZANIZI, EXPRESSING FULL SUPPORT TO SENATE BILL NO. 950 WHICH SEEKS TO LIBERALIZE THE IMPORTATION OF MOTOR VEHICLES BY LOWERING THE TARIFF SO THAT THE PRICE OF CARS BE WITHIN THE REACH OF THE AVERAGE WORKERS AND ALSO TO RESTRUCTURE THE BOARD OF INVESTMENTS WHICH HAD BEEN OVERLY PROTECTIVE TO ONLY TWO (2) AUTHORIZED CAR ASSEMBLERS IN THE PHILIPPINES.

WHEREAS, for the purpose of enlisting support, the City Council of
Oronix has furnished this august Body its Resolution No. 62 dated
February 21, 1987, expressing full support to Senate Bill No. 950 which
proposes to liberalize the importation of motor vehicles by lowering the
tariffs so that the price of cars can be within the reach of the average
worker and also to restructure the Board of Investments which has been
protectionist and only two (2) authorized car assemblers in the
Philippines.

WHEREAS it is a suspect Body, nonconforms to the embodiment of said Resolution No. 62 of the City Council of Granir and, believes as valid and very arbitrary the purposes of Senate Bill No. 950;




