A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE THE LUMP-SUM AMOUNT OF P300.00 AGAINST CURRENT APPROPRIATION ON SALARIES AND WAGES OF THE CITY MAYOR'S OFFICE, SAID AMOUNT AS PAYMENT OF THE 1988 CASH GIFT OF MR. FRANCISCO BALTONADO, MUSICIAN, OFFICE OF THE CITY MAYOR.

Presented for consideration is Voucher No. 1228 dated March 3, 1989 in the amount of Three Hundred Pesos (P300.00), to be charged against current appropriation on lump-sum for services and wages of the City Mayor's Office, to be made available as 1988 Cash Gift, (August 16 to October 31, 1988), of Mr. Francisco Baltonado as Musician, Office of the City Mayor, said employee not having as yet received his benefit of the 1988 Cash Gift;

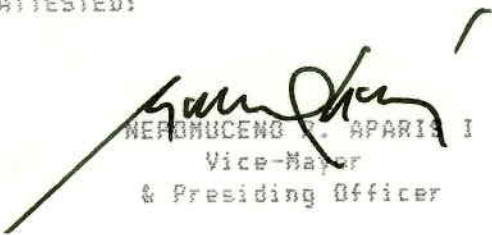

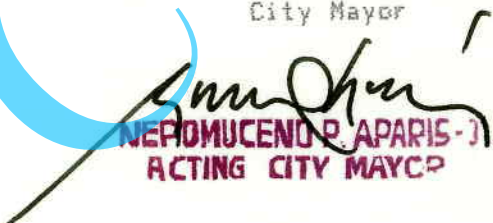
