A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR FOR AN AUTHORIZATION TO UTILIZE AN AMOUNT OF P39,274.20 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND FOR THE COMPLETION OF THE SPRING DEVELOPMENT WATER SYSTEM IN BARANGAY BAGONG, ORMOC CITY.

Bagong, Ormoc City, in the amount of P39,274.20 be funded from out of the 20% Economic Development Fund, (EDF), of the General Fund subject, however, to an authorization for this purpose granted by the Department of Local Government;

WHEREAS, the Honorable MEMBERS of the FIFTH SANGGUNIANG PANLUNGSOD NG ORMOC, in session, and, in keeping with the Program of the City Government for continuous and immediate services to its constituents in pursuance with its Development Objectives, (Underscoring Supplied), has enacted Resolution No. 44 embodying Appropriation-Ordinance No. 89-15, (a copy of which is hereto attached), approving IN PRINCIPLE an appropriation of P39,274.20, said amount or so much thereof to be made available for the completion of the Spring Development Water System in Brgy. Bagong, Ormoc City, the funding source of which to be taken from the 20% Economic Development Fund, (EDF), of the General Fund, SUBJECT, HOWEVER, TO AN AUTHORIZATION FOR THIS PURPOSE GRANTED BY THE DEPARTMENT OF LOCAL GOVERNMENT;
