RESOLUTION NO. 49

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE THE CLAIMS OF LEYECO V IN THE AMOUNT OF P75,482.11 REPRESENTING ELECTRIC BILLS OF THE SANGGUNIANG PANLUNGSOD BUILDING COVERING THE PERIOD FROM JUNE, 1981 TO DECEMBER, 1988 AGAINST CURRENT APPROPRIATION OF THE GENERAL FUND, AND, IN THE AMOUNT OF P102,718.57 REPRESENTING ELECTRIC BILLS OF ORMOC CITY STREETS LIGHTS COVERING THE PERIOD FROM AUGUST TO DECEMBER, 1988, AGAINST CURRENT APPROPRIATION OF THE INFRASTRUCTURE FUND.

WHEREAS, the Office of the Vice Mayor & Presiding Officer of the Sangguniang Panlungsod is in receipt of a Statement of Account or Electric Bill from LEYECO V, dated April 19, 1989, showing therein the total amount of Ninety Five Thousand Four Hundred Eighty Two Pesos & 11/100, (P95,482.11), payable to LEYECO V, representing electric consumption incurred in the Sangguniang Panlungsod building covering the period from June, 1981 to December, 1988, and, the same outstanding bill of account is being presented to the Honorable Members of the Sangguniang Panlungsod ng Ormoc, in session, for consideration purposes;

WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of another Electric Bill re Ormoc City Streets Lights, Ormoc City, from LEYECO V, through Engr. Ruben Penserga, City Engineer, this city, the same outstanding and payable amounts being reflected in two (2) Disbursement Vouchers Nos. 148 and 4228 in the amounts of P32,170.91 and P70,547.66, respectively, carrying the total amount of One Hundred Two Thousand Seven Hundred Eighteen Pesos & 57/100, (P102,718.57), to cover payments on electric consumption of streets lights for the period from August to December, 1988 and, with a letter from the City Engineer requesting this august Body to pass a resolution authorizing the City Treasurer to charge the herein claim of P102,718.57 against Current Appropriation, the fact that, as alleged therein, the allotment for streets lights for the year 1988 was already exhausted;

WHEREAS, the City Treasurer has assured this august Body of the availability of funds for the purpose; and

WHEREAS, this august Body considers the foregoing claims of LEYECO V reasonable, and, immediately be given due course and favorable consideration;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, severally seconded by mga Kagawad Eufrocino C. Codilla, Jr., Rodolfo L. Rivilla, Jr. and Celso P. Porcadilla; be it

RESOLVED, to pass a resolution authorizing the City Treasurer to charge the claims of LEYECO V on electric consumption in the aggregate sum of ONE HUNDRED NINETY EIGHT THOUSAND TWO HUNDRED PESOS & 68/100, (P198,200.68), against CURRENT APPROPRIATION of both:
