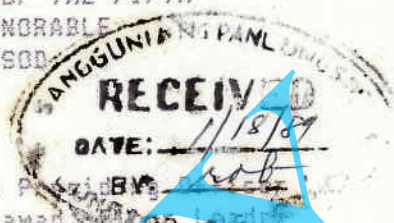

RESOLUTION NO. 5

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR MA. VICTORIA L. LOCSIN TO EXTEND THE DEADLINE FOR REGISTRATION OF PERMITS/ LICENSING OF BUSINESSES FROM JANUARY 20 TO JANUARY 31, 1989.

WHEREAS, the Fifth Sangguniang Panlungsod ng Ormoc is in receipt of Resolution No. 01, Series of 1989 of the Ormoc Filipino Retailers' Association, strongly requesting that representatives of all the departments who are involved in the processing of business permits/licensing be assigned in one place at the City Hall and to request also, that the deadline of registration of permits/licensing on Jan. 20 be extended to Jan. 31, 1989;

WHEREAS, the first request cannot be given due consideration because this august Body believes there is no need of a resolution, for this request is already implemented, considering that representatives from the Police Department, City Engineering Office and the City Fire Department are having their offices in one place inside the City Hall building that serve the purpose;

WHEREAS, this august Body finds it quite proper to temporarily suspend the operation of Section 1.2.1.4 of Tax Ordinance No. 1, otherwise known as the "Ormoc City Revenue Code of 1977", fixing the first twenty (20) days of January to pay tax obligations, to give the taxpayers ample time to meet the various requirements;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, unanimously seconded; be it

RESOLVED, to authorize the Honorable City Mayor Ma. Victoria L. Locsin to extend the deadline for registration of permits/licensing of businesses from January 20 to January 31, 1989;


