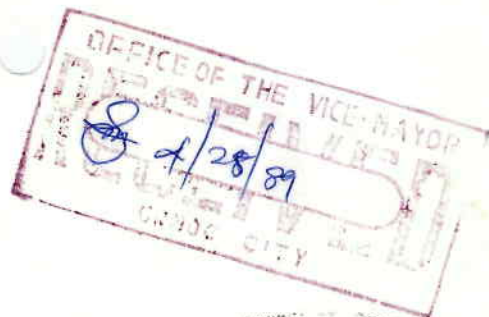

RESOLUTION NO. 50

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR MA. VICTORIA L. LOCSIN TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT WITH THE HOUSING AND LAND USE REGULATORY BOARD, (HLRB), REPRESENTED BY ITS DULY AUTHORIZED REPRESENTATIVE, THE REGIONAL TECHNICAL COORDINATOR WITH HIS TECHNICAL ASSISTANT.

WHEREAS, there is now being prepared a Memorandum of Agreement to be signed by the Honorable City Mayor, Honorable Ma. Victoria L. Locsin, for and in behalf of the City Government of Ormoc, with the Housing and Land Use Regulatory Board, (HLRB), a government agency duly organized and existing by virtue of Executive Order No. 648, represented by its duly authorized representative, Regional Technical Coordinator Florencio P. Tingzon, Jr., Region 8, Tacloban City with his Technical Assistant;

WHEREAS, LOI No. 729 and EO 648 require all local government units to prepare and formulate land use plans and zoning regulations and submit the same to HLRB for review and ratification;

WHEREAS, the HLRB, pursuant to the provisions of its Charter, has formulated and adopted a national city planning program and has full institutional capabilities in terms of facilities and expertise to prepare city plans and is willing to join hands with and assist the City Government of Ormoc City in carrying out its city planning project;

WHEREAS, the Fifth Sangguniang Panlungsod ng Ormoc has enacted Resolution No. 47 on April 20, 1989, the same resolution having embodied Appropriation Ordinance No. 89-16 appropriating an amount of Twenty Five Thousand Pesos, (P25,000.00), to be made available as initial budget expense for the replanning and rezoning of the City of Ormoc to take for about nine (9) months program of work, the passage of said Resolution No. 47 is being made possible due to the request of Engr. Nestor C. Penserga, Coordinator, City Planning and Development Board, this city;

NOW, THEREFORE, on motion of Kagwad Arnulfo C. Salazar, severally seconded by mga Kagawad Eufrocino C. Codilla, Jr., Gregorio A. Yrastorza, Jr. and Celso P. Porcadilla; be it

Locsin, to sign, for and in behalf of the City Government of Ormoc, a Memorandum of Agreement with the Housing and Land Use Regulatory Board, (HLRB), represented by its duly authorized representative, Regional Technical Coordinator Florencio P. Tingzon, Jr., Region 8, Tacloban City, with his Technical Assistant;


