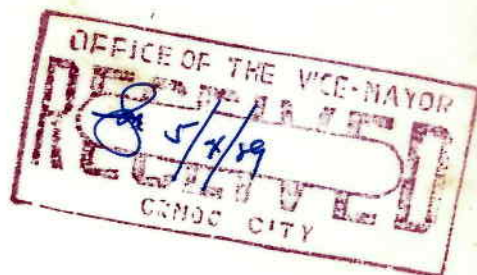

RESOLUTION NO. 53

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC CITY TO UTILIZE THE AMOUNT OF P45,000.00, AS BUDGETED COSTS FOR TWO (2) WATERWORKS IMPROVEMENT PROJECTS, FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND.

WHEREAS, this august Body is in receipt of a communication dated April 4, 1989 from Engr. Gervacio L. Germano, Jr., Waterworks Superintendent II, Ormoc Waterworks Division, Office of the City Administrator, mentioning therein that, for so long a time now, the residents in Sitio Tinag-an, Brgy. Ipil, Ormoc City and that of Ruby Village, Brgy. Punta, Ormoc City, have been complaining that they have practically no potable water for drinking, cooking, etcetera, and have requested the Ormoc Waterworks Office for assistance. Thus, two (2) projects proposals re Proposed Waterworks Improvement Projects for Sitio Tinag-an and another for Ruby Village are submitted for consideration, carrying a total appropriation of Forty Five Thousand Pesos, (P45,000.00), the same being broken down as follows:

Waterworks Improvement Project:

a) Sitio Tinag-an, Brgy. Ipil, Ormoc City P25,700.00
b) Ruby Village, Brgy. Punta, Ormoc City 19,300.00

TOTAL P45,000.00

WHEREAS, the City Budget Officer, this city, has recommended that the financial requirement of the amount of Forty Five Thousand Pesos, (P45,000.00), for waterworks improvement, (for Sitio Tinag-an, Brgy. Ipil, Ormoc - P25,700.00, and for Ruby Village, Brgy. Punta, Ormoc City - P19,300.00), be taken from the 20% Economic Development Fund - a continuing appropriation of the General Fund;

WHEREAS, the Honorable MEMBERS of the FIFTH SANGGUNIANG PAMLUNGSOD ng ORMOC, in session, and, in keeping with the Program of the City Government for continuous and immediate services to its constituents in pursuance with its Development Objectives, (Underscoring Supplied), has enacted Resolution No. 52 embodying Appropriation Ordinance No. 89-19, (a copy of which is hereto attached), approving IN PRINCIPLE an appropriation of P45,000.00, from out of the 20% Economic Development Fund, said amount or so much thereof to be made available as the budgeted costs for the aforementioned two (2) waterworks improvement projects, subject, however, to an authority for this purpose granted by the Department of Local Government;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, duly seconded by Kagawad Celso P. Porcadilla; be it

RESOLVED, to pass a resolution EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH HONORABLE RESURRECCION S. SALVATIERRA, REGIONAL DIRECTOR, DLG, REGION VIII, TACLOBAN CITY, TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC CITY TO UTILIZE THE AMOUNT OF P45,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND TO BE MADE AVAILABLE AS BUDGETED COSTS FOR THE TWO (2) AFOREMENTIONED WATERWORKS IMPROVEMENT PROJECTS, namely:

At Sitio Tinag-an, Brgy. Ipil, Ormoc	-	P25,700.00
At Ruby Village, Brgy. Punta, Ormoc	-	19,300.00
