RESOLUTION NO. 53

A RESOLUTION CREATING THE COMMITTEE ON ETHICS, THE SAME TO BE APPENDED IN THE COMMITTEE ON GOOD GOVERNMENT, TO READ NOW AS THE COMMITTEE ON GOOD GOVERNMENT AND ETHICS, AND AMENDING FOR THIS PURPOSE RULE IV SECTION I SUB-SECTION I OF RESOLUTION NO. 8, S. 1988.

WHEREAS, in the formulation of the House Rules and Procedures of the Fifth Sangguniang Pamungsaod ng Ormog as embodied in Resolution No. 8, s. 1988, more specifically in the formation and creation of the Standing Committee thereof, there has been an apparent omission in creating one (1) important committee, the Committee on Ethics, to deal on matters relating to the proper conduct and upright decorum of local government officials, to promulgate rules and regulations appertaining thereto, to conduct investigation on any misconduct or misdemeanor of local government officials reported to the committee and, to give the proper recommendation/s to be instituted regarding such misconduct or misdemeanor;

WHEREAS, the proposed Committee on Ethics has pivotal functions, (as above stated), the implementation of which may lead, in one way or another, to the appearance or existence of a good and ideal government;

WHEREAS, the proposed Committee on Ethics can consistently or compatibly be joined or included in the Committee on Good Government, the former committee may be regarded to as one of the tools to a clear realization of the aims and objectives of the latter committee, and, for the Chairman of the Committee on Good Government to be one and the same Chairman for the Committee on Ethics;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, jointly seconded by mga Kagawad Eufrocino C. Codilla, Jr. and Benjamin F. Tugonon; be it

RESOLVED, to pass a resolution creating the Committee on Ethics, the same to be appended in the Committee on Good Government, to read now as the Committee on Good Government and Ethics, and, amending for this purpose Rule IV Section I Sub-section I of Resolution No. 8, s. 1988.

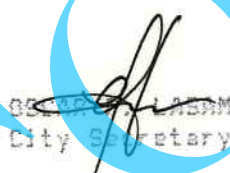
RESOLVED, FURTHER, to designate as Chairman of the Committee on Good Government and Ethics the incumbent Chairman of the amended Committee on Good Government;

ENACTED, May 4, 1989.

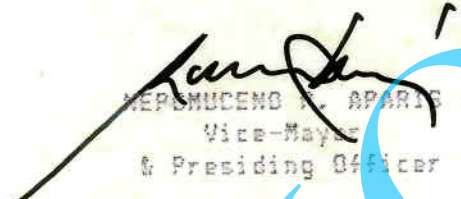

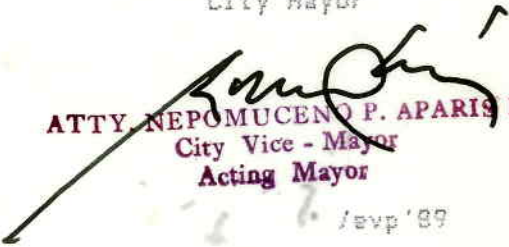
