

RESOLUTION NO. 63

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR TO AUTHORIZE THE HONORABLE CITY MAYOR OF BRMOC CITY TO UTILIZE THE AMOUNT OF P70,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND OF THE GENERAL FUND TO THE ACCOUNT - MANAGEMENT TOOL (BARANGAY SEMINARS), TO DEFRAY THE EXPENSES ON FORTHCOMING ORIENTATION SEMINAR OF BARANGAY OFFICIALS OF BRMOC CITY, MAY 21, 1987, AT AREA V COMPOUND, ORMOC CITY.

WHEREAS, this august Body is in receipt of a letter from Mr. Bienvenido A. Matiga, Senior Community Affairs Officer, City Mayor's Office, re: requesting for Supplemental Appropriation in the amount of Seventy Thousand Pesos, (P70,000.00), to defray the expenses for lunch and the per diems of berangay officials on forthcoming Orientation Seminar of Barangay Officials of Ormoc City on May 21, 1987 at Area V Compound, Ormoc City;

WHEREAS, per referral to the City Budget Officer, this city, for funding purposes, this said officer has recommended that the financial requirement of the Supplemental Appropriation in the amount of Seventy Thousand Pesos, (P70,000.00), for the Orientation Seminar of the newly rejected Barangay Officials of Ormoc City, be taken from out of the reversion of 20% Economic Development Fund of the General Fund to the account - Management Tool (Barangay Seminars);

WHEREAS, due to time element and the relevance of the aforesaid prientation seminar of the newly-elected barangay officials, (which, aside electing their Board Members and, ultimately, their ABC President, these barangay officials must be brief of the fundamental tenets of a democratic government, of their duties and functions, their involvement to community services and to the government), the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in session, has enacted Resolution No. 62 embodying Appropriation Ordinance No. 89-24, (a copy of which is

hereto attached), approving IN PRINCIPLE an appropriation of P70,000.00, said amount or so much thereof to be made available to defray the expenses for lunch and the per diems of barangay officials who are to undergo the orientation seminar, subject, however, to an authority for this purpose granted by the Department of Local Government;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, duly seconded by mga Kagawad Celso P. Adolfo and Rodolfo L. Rivilla, Jr; be it

RESOLVED, to pass a resolution EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH DIRECTOR RESURRECCION S. SALVATIERRA, REGIONAL DIRECTOR, DLG, REGION VIII, TACLOBAN CITY, TO AUTHORIZE THE HONORABLE CITY MAYOR OF DRMCC CITY TO UTILIZE THE AMOUNT OF P70,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND OF THE GENERAL FUND TO THE ACCOUNT - MANAGEMENT TOOL (BARANGAY SENINARS), TO DEFRAY EXPENSES ON FORTHCOMING ORIENTATION SEMINAR OF BARANGAY OFFICIALS OF DRMCC CITY, May 21, 1989 at Area V Compound, Ormoc City:
