

RESOLUTION NO. 64

A RESOLUTION RESPECTFULLY ADDRESSED TO THE HONORABLE PRESIDENT OF THE SENATE AND THE HONORABLE SPEAKER OF THE HOUSE OF REPRESENTATIVES, EARNESTLY REQUESTING AND URGING CONGRESS OF THE PHILIPPINES TO LEGISLATE AND DEFINE WHAT ARE HEINOUS CRIMES, AS PROVIDED IN THE 1987 CONSTITUTION, SO THAT DEATH PENALTY COULD BE PROPERLY IMPOSED ON THE OFFENDERS.

WHEREAS, death penalty on capital offenses has been abolished in the 1987 Constitution, except heinous crimes;

WHEREAS, it has been the observation of many, that, in the disposition of cases, courts dispose cases, the maximum penalty imposed to criminals on capital offenses is only Life Imprisonment notwithstanding the gravity of the offense, the commission of which so revolting to the orderliness in society and downright shocking to the conscience of the peace-loving members of the community;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, jointly seconded by mga Kagawad Celso P. Adolfo and Benjamin F. Tugonon; be it

RESOLVED, to pass a resolution respectfully addressed to the Honorable President of the Senate and the Honorable Speaker of the House of Representatives, to EARNESTLY REQUEST AND URGE CONGRESS OF THE PHILIPPINES TO LEGISLATE AND DEFINE WHAT ARE HEINOUS CRIMES, AS PROVIDED IN THE 1987 CONSTITUTION, SO THAT DEATH PENALTY COULD BE PROPERLY IMPOSED UPON THE OFFENDERS;

ENACTED, May 11, 1989.


