

RESOLUTION NO. 69

A RESOLUTION EARNESTLY AND URGENTLY REQUESTING ADMINISTRATOR RODRIGO CABRERA, NATIONAL ELECTRIFICATION ADMINISTRATION (NEA), TO INCLUDE LEYECO V, IN ORMOC CITY, IN THE BUDGET FOR THE EXPANSION OF POWER LINES IN THE FUNDING FROM THE 16TH YEN LOAN PACKAGE AS ENDORSED BY HER EXCELLENCY, PRESIDENT CORAZON C. AQUINO, TO THE NATIONAL ECONOMIC DEVELOPMENT AUTHORITY (NEDA).

WHEREAS, in spite of the laudable efforts of the management of LEYECO V to serve the electrical power needs of the barangays of Ormoc City, there are still several barangays and sitios not enjoying the blessings of electrical power;

WHEREAS, Her Excellency, President Corazon C. Aquino, has already endorsed the NEA budget requirements to the National Economic Development Authority, (NEDA), for inclusion in the 16th yen loan package;

WHEREAS, the apparent inability of LEYECO V to extend power lines to the other barangays of Ormoc City is may be due to lack of funds;

NOW, THEREFORE, on motion of Kagawad Romeo M. Hermosilla, duly seconded by Kagawad Gregorio A. Yrastorza, Jr.; be it

RESOLVED, to pass a resolution earnestly and urgently requesting Administrator Rodrigo Cabrera of the National Electrification Administration, (NEA), to include LEYECO V in Ormoc City, in the budget for expansion of power lines in the funding from the 16th yen loan package as endorsed by Her Excellency, President Corazon C. Aquino, to the National Development Authority, (NEDA);

Locsin, City Mayor, Ormoc City; and, the Management - LEYECO V, Ormoc City;

CARRIED. Six (6) affirmative votes; one (1) objection registered by Kagawad Eufrocino C. Codilla, Jr.; and, four (4) abstentions registered by mga Kagawad Arnulfo C. Salazar, Benjamin F. Tugonon, Jose B. Canales, and Celso P. Adolfo.
