

RESOLUTION NO. 74

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE SECRETARY OF FINANCE
TO AUTHORIZE THE OFFICER-IN-CHARGE OF THE CITY ASSESSOR'S OFFICE IN
ORMOC CITY TO CONDUCT A GENERAL REVISION IN SAID OFFICE PURSUANT TO
SECTION 21 OF PD 464.

WHEREAS, this august Body is in receipt of a letter from Mr. Bricio D. Supremo, OIC, City Assessor's Office, this city, requesting passage of a resolution requesting the Honorable Secretary of Finance to grant an authority to the OIC, City Assessor's Office of Ormoc, authorizing said government official to conduct a general revision in said office pursuant to Section 1 of PD 464;

WHEREAS, Section 1 of PD 464 provides, in portion, that a general revision every after three (3) years is allowable; and, that the City Assessor's Office in Ormoc has not as yet undergone general revision for the past six (6) years;

WHEREAS, this august Body believes that the aforesaid request is reasonable and in keeping with the program of the City Government on increasing revenues;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, duly seconded by Kagawad Eufracino C. Cadilla, Jr.; be it

RESOLVED, to pass a resolution earnestly requesting the Honorable Secretary of Finance to authorize the Officer-In-Charge of the City Assessor's Office in Ormoc City to conduct a general revision in said Office pursuant to Section 21 of PD 464;
