RESOLUTION NO. 78

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC CITY TO UTILIZE THE AMOUNT OF P30,000.00 FROM THE 20% ECONOMIC DEVELOPMENT FUND OF THE GENERAL FUND FOR FUNDING THE ON-GOING INTER-BARANGAY SPORTSFEST '89 IN ORMOC CITY.

WHEREAS, Honorable Mayor Ma. Victoria L. Loresin of Ormoc City has requested in writing the Honorable Sangguniang Panlungsod ng Ormoc for an appropriation of Thirty Thousand Pesos, (P30,000.00), to be made available to finance the on-going Inter-Barangay Sportsfest '89 in Ormoc City, and, has further recommended that the availability of funds thereof be taken from out of the 20% Economic Development Fund, (EDF), of the General Fund, for the continuing inter-barangay sports program of the City Government;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in session, on consideration that the aforesaid request is very commendable, the same being in keeping with the program of the government on plans to encourage the youth to develop interest and involvement in sports and athletic activities, (one diversionary way to discourage the youth on being indulged to vices and, with a logical proceeding sequence on reducing criminality), has enacted IN PRINCIPLE the appropriation of the sum of THIRTY THOUSAND PESOS, (P30,000.00), for the aforesaid purpose, said amount to be sourced from the General Fund, from out of the 20% Economic Development Fund (EDF), subject, however, to the authority for this purpose granted by the Department of Local Government.

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, duly seconded by Kagawad Gregorio A. Yrastorza, Jr.; be it

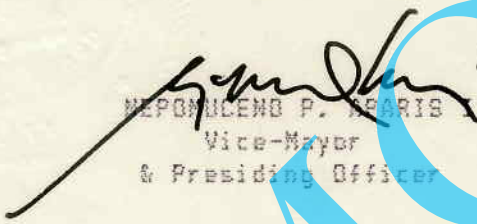

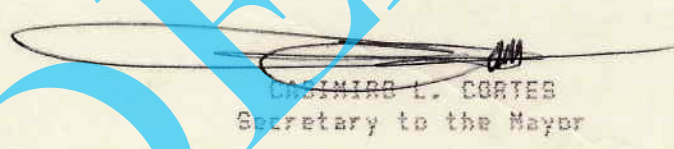
