

RESOLUTION NO. 80

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT THE  
DONATION OF BARANGAY BALION OF TWELVE (12) UNITS FLUORESCENT  
LIGHTING FIXTURES, 20-WATT, 220 VOLTS, COMPLETE WITH WEATHER  
PROTECTOR AND MOUNTING BRACKET TO THE CITY GOVERNMENT OF ORMOC, AND  
AUTHORIZING THE CITY TREASURER TO PAY THE ELECTRIC BILLS FOR THESE  
LIGHTS NOT TO EXCEED 250 WATTS PER MONTH.

WHEREAS, the Barangay Council of Balion, by its Resolution No. 2,  
s. 1989, is donating twelve (12) units Fluorescent lighting fixtures,  
20-watt, 220 volts, complete with weather protector and mounting  
bracket, to the City Government of Ormoc, with the request that the  
billings of electrical consumption to a total of 250 watts per month be  
paid by the City Treasurer of Ormoc City;

WHEREAS, this august Body considers this gesture and manifestation  
of Barangay Balion laudable, and, must be given due course and favorable  
consideration;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, duly

mounting bracket to the City Government of Ormoc and, to authorize the  
City Treasurer to pay the electric bills for these lights not to exceed  
250 watts per month;


