RESOLUTION NO. 83

A RESOLUTION FORMALLY NOTIFYING THE OFFICE OF THE PRESIDENTIAL
MANAGEMENT STAFF THROUGH UNDER-SECRETARY ELEN M. CRUZ OF THE SAME
OFFICE RELATIVE THE INTENTION OF THE CITY GOVERNMENT OF ORMOC TO
OCCUPY THE BUILDING AND OTHER IMPROVEMENTS THEREON OF LOT NO. 4486-
A-2 AT BARANGAY SAN PABLO, ORMOC CITY.

WHEREAS, the City Government of Ormoc has acquired Lot No. 4486-A-
2 with the improvements thereon situated at Brgy. San Pablo (Simangan),
this city, from Mrs. Rosalia Tan Tomada and her daughter;

WHEREAS, for purposes of a provincial action center of the then
Ministry on Human Settlements, the aforementioned lot was occupied with
consent by the said Ministry and, should said Ministry no longer need or
use the lot, the same be returned to the City together with all the
improvements thereon;

WHEREAS, inspite diligent efforts exerted, none whatsoever is found
of any proper deed of donation evidencing formal transfer of title of
the said property in favor of the then Human Settlements Commission;

WHEREAS, lately, the Department of Agrarian Reforms, (or DAR), has
occupied Lot No. 4486-A-2 with its improvements based on a Memorandum of
Agreement signed between the two Offices, the Presidential Management
Staff and the Office of the DAR, wherein the Presidential Management
Staff, as caretaker of the Department of Human Settlements Commission,
has allowed DAR the use and occupancy of said lot;

WHEREAS, ownership of Lot No. 4486-A-2 with the building and other
improvements thereon, still remains in the City Government, the latter
with the intention of occupying said property for very relevant public
purposes;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, Chairman, Committee on Public Properties, severally seconded by mga Kagawad Eufrocino C. Codilla, Jr., Celso P. Adolfo, Benjamin F. Tugonon and Celso P. Porcadilla; be it

RESOLVED, to pass a resolution formally notifying the Office of the Presidential Management Staff through Under-Secretary Elfren M. Cruz of the same Office relative the intention of the City Government of Ormoc to occupy the building and other improvements thereon of Lot No. 4486-A-2 situated at Brgy. San Pablo, (formerly Simangan), Ormoc City;
