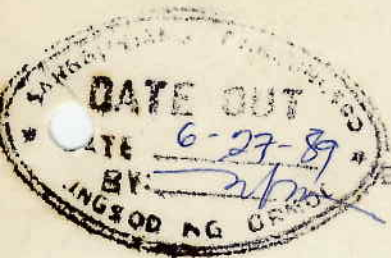
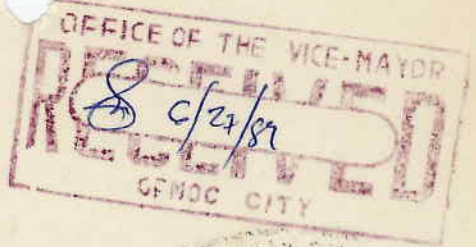
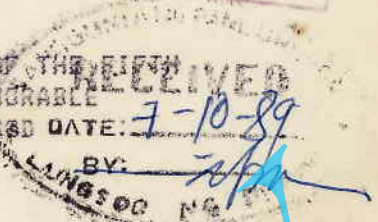

RESOLUTION NO. 85

A RESOLUTION AMENDING THE REORGANIZATIONAL STAFFING PATTERN
TRANSFERRING NOS. 161 TO 163 FROM THE OFFICE OF THE DEPARTMENT OF
LOCAL GOVERNMENT TO THE OFFICE OF PUBLIC AFFAIRS, INFORMATION AND
ASSISTANCE DIVISION UNDER THE OFFICE OF THE CITY MAYOR.

WHEREAS, the Honorable Mayor Ma. Victoria L. Locois, this city,
has written a letter-request dated March 16, 1989 addressed to Executive
Secretary Gaudioso C. Cosmena, Jr., Director, Joint Commission on Local
Government, (Personnel Administration), Manila, requesting for transfer
of the three (3) positions of Community Affairs Workers, (or of Item
Nos. 161 to 163 with incumbents Lilian Antonio, Renaida Morca and
Rodrigo Rivera, respectively), from as support to a national office, -
the Department of Local Government, (City Development Office), to the
Office of Public Affairs, Information and Assistance Division, both
Offices under the Office of the City Mayor, which, in effect, amending
the approved reorganizational Position Classification and Pay Plan,
(PCPP), of the Local Government of Ormoc City;

WHEREAS, the Joint Commission on Local Government, Manila, has
responded to the aforesaid request, so stating "that transfer of local
government positions from one division to another under the same office
requires no further authority from the Joint Commission," and further
stated: It is understood that the revised allocation list attached to
Joint Commission approval of the staffing pattern of the city shall be
amended accordingly";

WHEREAS, this august Body believes that a resolution is proper and
necessary to formalize the transfer of Items 161 to 163 from the Office
of the Department of Local Government to the Office of Public Affairs,
Information and Assistance Division, Office of the City Mayor, this,
being the substance of the request of the Honorable City Mayor to the
Joint Commission on Local Government, and, this resolution is in

consonance with what is manifested by Executive Secretary G. C. Sosmena, Jr., Joint Commission on Local Government, on having considered as "understood that the revised allocation list X X X of the staffing pattern of the city shall be amended accordingly";

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrasterza, Jr., duly seconded by Kagawad Celso P. Adolfo; be it

RESOLVED, to pass a resolution amending the Reorganizational Staffing Pattern transferring Nos. 161 to 163 from the Office of the Department of Local Government to the Office of the Public Affairs, Information and Assistance Division under the Office of the City Mayor;

ENACTED, June 13, 1989.

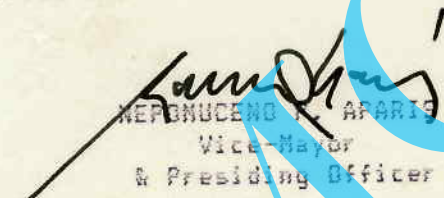
