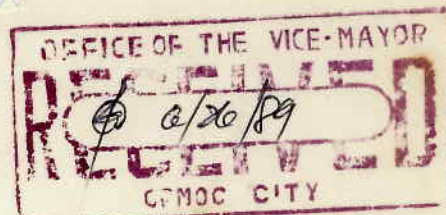

RESOLUTION NO. 89

A RESOLUTION EARNESTLY REQUESTING HER EXCELLENCY, PRESIDENT CORAZON C. AQUINO, TO DECLARE JUNE 29TH OF EVERY CALENDAR YEAR, A SPECIAL NON-WORKING HOLIDAY IN ORMOG CITY, THE SAME BEING THE CITY FIESTA CELEBRATION IN HONOR OF PATRON SAINTS PETER AND PAUL.

WHEREAS, Ormog City commemorates its City Fiesta on June 29th of each year in honor of Patron Saints Peter and Paul;

WHEREAS, the celebration of the City Fiesta on said date has always been observed by the Ormocanons in keeping with its cultural and traditional heritage;

WHEREAS, in order to give the people of Ormog a chance to enjoy and reflect on the significance of the day as a fitting tribute to its Patron Saints, it is necessary that the government employees both in the local and national levels in the City of Ormog be afforded a free day;

WHEREAS, the declaration of a non-working holiday is within the powers and prerogatives of the President of the Philippines as Chief Executive of the land;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., duly seconded by Kagawad Arnulfo C. Salazar; be it

RESOLVED, to pass a resolution earnestly requesting Her Excellency, President Corazon C. Aquino, to declare June 29th of every calendar year, a Special Non-Working Holiday in Ormog City, the same being the City Fiesta Celebration in honor of Patron Saints Peter and Paul;

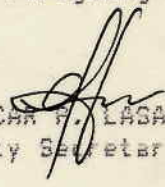
