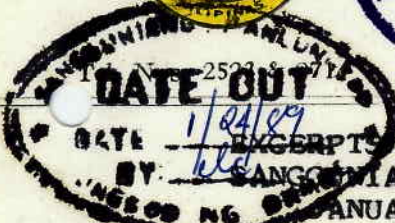

**RESOLUTION NO. 9
Series of 1989**

A RESOLUTION RECOMMENDING THE ADOPTION BY THE COMMISSION ON ELECTIONS (COMELEC) OF RESOLUTION NO. 88-199 S. 1988 OF THE SANGGUNIANG PANLUNGSOD OF TACLOBAN CITY, URGING THAT AUGUST BODY TO DECIDE, ONCE AND FOR ALL, THE GUBERNATORIAL CONTEST IN THE PROVINCE OF LEYTE AND TO PROMULGATE AND ANNOUNCE THE RESULTS OF SAID CONTEST.

"WHEREAS, the 5th Sangguniang Panlungsod Ng Ormoc is in receipt of a copy of Resolution No. 88-199 s. 1988 of the Sangguniang Panlungsod of Tacloban City, urging the Commission on Elections (COMELEC) to decide, once and for all, the gubernatorial contest in the Province of Leyte in the last local elections and to announce results of said contest;

"WHEREAS, this august body is aware of, and is apprehensive of the fact that in spite of the lapse of one year since the elections in said province, no decision has been arrived at regarding the results of the gubernatorial contest;

"WHEREAS, the situation obtaining in the province denies residents and constituents the vital services of the popularly elected Governor of the province;

"WHEREAS, the progress of the City of Ormoc and the Province of Leyte hinges on the symbiotic interaction of the constituents with the nation in general, secondarily, with the region, but most particularly, with the Province of Leyte;

"WHEREAS, the existing "tragedy of indecision" considerably has hampered the progress of the area because investors are still undecided due to the absence of a duly elected Governor of the Province;

"SO, NOW, THEREFORE, on motion of ABC President and Kagawad Romeo M. Hermosilla, duly seconded by Kagawads Arnulfo C. Salazar, Rodolfo L. Rivilla, Jr., Benjamin F. Tugonon and Celso P. Porcadilla; be it

"RESOLVED, to pass a resolution recommending the adoption by the Commission on Elections (COMELEC) of Resolution No. 88-199 s. 1988, of the Sangguniang Panlungsod of Tacloban City, urging that august Body, to decide, once and for all, the gubernatorial contest in the Province of Leyte and to promulgate and announce the results of said contest;

"RESOLVED FURTHER, to furnish a copy each of this resolution to, Her Excellency, President Corazon C. Aquino, President of the Republic of the Philippines, at Malacañang, Manila; Honorable Carmelo J. Locsin, Congressman, 4th District, Leyte, at the House of Representatives, Manila; Honorable Ma. Victoria L. Locsin, City Mayor, Ormoc City; Honorable Uldarico Mate, City Mayor, Tacloban City; the Honorable Sangguniang Panlungsod, Tacloban City; and, one copy to be posted at the Bulletin Board of the Sangguniang Panlungsod, Ormoc City.
