


RESOLUTION NO. 90

A RESOLUTION FAVORABLY INDORSING AND SUPPORTING RESOLUTION NO. 214,
S. 1989 OF THE SANGGUNIANG PANLALAWIGAN OF SURIGAO DEL SUR, URGING
HER EXCELLENCY, CORAZON C. AQUINO, PRESIDENT OF THE REPUBLIC OF THE
PHILIPPINES, THRU HONORABLE JOSE CONCEPCION, SR., SECRETARY OF
COMMERCE AND INDUSTRY, TO CONSIDER AS PRESSINGLY URGENT, THEREFORE,
TO CREATE A PRICE STABILIZATION AND CONTROL COUNCIL TO CHECK,
MINIMIZE, IF NOT PUT TO A HALT, THE ABUSES OF SOME UNCRUPULOUS
BUSINESSMEN WHO TAKE ADVANTAGE OF SITUATIONS IN CRISIS, BY HOARDING
AND THEREAFTER JACKING-UP TREMENDOUSLY PRICES OF COMMODITIES IF
ONLY TO PROTECT AND PRESERVE THE BEST INTEREST AND WELFARE OF THE
VAST MAJORITY OF THE COMMON MAN.

WHEREAS, the Sangguniang Panlungsod ng Oromoc is in receipt of
Resolution No. 214, s. 1989 of the Sangguniang Panlalawigan of Surigao
del Sur, urging Her Excellency, Corazon C. Aquino, President of the
Republic of the Philippines, through Honorable Jose Concepcion, Sr.,
Secretary of Commerce and Industry, to consider as pressingly urgent,
therefore, to create a Price Stabilization and Control Council to check,
minimize, if not put to a halt, the abuses of some unscrupulous
businessmen who take advantage of situations in crisis, by hoarding and
thereafter jacking-up tremendously prices of commodities if only to
protect and preserve the best interest and welfare of the vast majority
of the common man;

WHEREAS, this august Body conforms to the substances of said
resolution, very particularly now that prices in practically all
commodities keep on spiraling up overnight;
