## RESOLUTION NO. 91

A RESOLUTION EARNESTLY AND URGENTLY REDUESTING HONORABLE COMBRESSMAN CARMELO J. LOCSIN, FOURTH CONGRESSIONAL DISTRICT, LEYTE, TO PRESENT AND FILE A BILL IN CONGRESS AS AN ENABLING ACT RECLASSIFYING BRNDC DISTRICT MOSPITAL IN ORNOC CITY TO ORNOC REGIONAL HOSPITAL, WITH A MINIMUM BED CAPACITY OF 200 BEDS.

WHEREAS, according to reliable Situational Analysis reports, Grmoc City which is located in the Morthwestern part of Leyte, is the most populous single community in Region VIII where the Ormoc District Hospital, a 125-bed capacity provincial tertiary level health facility of the Department of Health, is located, and, which hospital is presently servicing a catchment area of four (4) municipalities and one (1) city with an estimated 1988 total population of 237,793 people;

WHEREAS, in the province of Leyte with a total population of about 1,373,927 of which about 713,597 or 52% of the total population is in the western part of Leyte, and, together with the population of the subprovince of Biliran, the main access of these vast community to the neighboring provinces in Central Visayas, Luzon and Mindanao, is Grace City due to the central and strategic location of the place, the existence of the Philippine-Japan-Highway and other road network, accessibility by air and sea and available transport facilities which a common traveler and businessman can afford;

aside population growth, with the boom of the WHEREAS, agricultural sector and the improvement of road systems, within a 30hilometer radius of Ormoc City, also have the lively growth of the following industries, namely: two (2) Sugar Mills, a Flour Mill-export

priented, Tile Factory, Cottage Industry - with emport potential, Seothermal Electric Plant, Bentonite Mine, Fertilizer Factory and Cooper

WHEREAS, with the aforecited situation in demography and socioeconomic conditions and changes of Ormoc City, the health patterns, too, are expected to change, and, in fact have already changed from plain tertiary care to a need for a more specialized medical services in the medical and sub-specialties offered by Regional Hospitals and Medical Centers;

WHEREAS, Ormor District Hospital, the second biggest hospital in Region VIII with regards to bed capacity, capability and performance is now thrust into the forefront, the focal point for referral of more complicated medical cases for expert management coming from the following hospitals/clinics:

- 1. Biliran Provincial Hospital, Maval, Biliran Sub-Province
- 2. Northwestern Leyte District Hospital, Calubian, Leyte
- 3. Western Leyte District Hospital, Baybay, Leyte
- 4. Hilongos District Hospital, Hilongos, Leyte 5. Southern Leyte Provincial Hospital, Massin, Southern Leyte
- 6. Palompon District Hospital, Palompon, Leyte
- 7. PNOC Hospital, Tungonan, Ormoc City
- 8. PHILPHOS Hospital, Isabel, Leyte
- 9. PASAR Hospital, Isabel, Leyte

WHEREAS, the biggest hospital in Eastern Visayas is the Tacloban City Medical Center, Tacloban City, a regional medical center that is 109-kilometer distance away from Brace City, 70% of its patients come from within a 20-kilometer radius of Tacloban City and could hardly cope up with the medical demands of the region;

WHEREAS, aside from the Medical Center in Tacloban City, there is no Regional Hospital which is presently in operation in whole of Region VIII; and

a social legislation is very indispensable to bridge the WHEREAS, gap between demand/need and the availability of functional appropriate heelth services, that which will provide the greatest good to the greatest number of people in Region VIII, as well as more benefits especially to those who have less in life;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorra, Jr., duly seconded by Kagawad Arnulfo C. Salazar; be it

RESOLVED, to pass a resolution earnestly and urgently requesting Honorable Congressman Carmelo J. Locsin, Fourth Congressional District, Province of Leyte, TO PRESENT AND FILE A BILL IN CONGRESS AS AN ENABLING ACT RECLASSIFYING BRNGC DISTRICT HOSPITAL IN BRNGC CITY TO BRNGC REGIONAL HOSPITAL, WITH A MINIMUM BED CAPACITY OF 200 BEDS;
