WHEREAS, this august Body is in receipt of Resolution No. 89-133 s.
1989 of the Sangguniang Panlalawigan ng Kalinga-Apayao, requesting the
Joint Commission on Local Government Personnel Administration, Manila,
to repair its erroneous stand in placing the position of the Provincial,
City and Municipal Secretaries on the level of Assistant Department Head
in respect for the provisions of Section 199 and Article IV of Batas
Pambansa Blg. 337, otherwise known as the Local Government Code, which
specifically provided that the Provincial Secretary is among the major
officials of the province, and that nowhere in the same Code does it
classify the Provincial, City or Municipal Secretary as Assistant
Department Head;
