A RESOLUTION EARNESTLY REQUESTING AND URGING HER EXCELLENCY,
PRESIDENT CORAZON C. AQUINO, TO DIRECT THE NATIONAL ELECTRIFICATION
ADMINISTRATION (NEA) TO DELIVER 500 ELECTRICAL POSTS TO ORMOC CITY
THROUGH LEYECO V.

WHEREAS, a good number of the old electric posts in Ormoc City and
its surrounding barangays are currently in the state of deterioration,
some of them are already damaged due to the succeeding typhoons which
visited Ormoc during the previous months;

WHEREAS, due to the increased electrical installations and new
extensions of electrical wirings brought about by the recent growth or
expansion of Ormoc City, additional electrical posts are needed for
placement at strategic and critical areas;

WHEREAS, based on the conditions as afore-explained, it becomes,
therefore, very indispensable to urgently request delivery of new
electrical posts for Ormoc City;
