A RESOLUTION ENDORSING WITH FULL SUPPORT RESOLUTION NO. 299 S. 1989 OF THE SANGGUNIANG PANLALAWIGAN NG BOHOL, ENTITLED, "A RESOLUTION OPPOSING THE OPENING OF MANILA JAI-ALAI FRONTON AS WELL AS THE REOPENING OF JAI-ALAI CEBU FRONTON TO SAFEGUARD AGAINST THE RESURGENCE OF CRIMES AND OTHER ILL-EFFECTS THAT JAI-ALAI FRONTONS WILL BRING TO THE SOCIETY."
