RESOLUTION NO. 05

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO EXTEND THE DEADLINE FOR REGISTRATION/RENEWAL OF PERMITS/LICENSING OF BUSINESSES FROM JANUARY 20 TO JANUARY 31, 1990.

WHEREAS, the Honorable SANGGUNIANG PANLUNGSOD ng ORMOC is in receipt of a letter from the Ormoc Filipipo Retailers Association, this city, addressed to Her Honor, the City Mayor, the latter having endorsed the same to this august Body, said letter having requested for extension of the Deadline for Registration/Renewal of Permits/Licensing of businesses from January 20 to January 31, 1990, alleging therein, among others, the tight financial situation wherein members of said association have encountered difficulties in raising funds to answer for payment of the different taxes imposed;

HEREAS, this august Body considers logical to temporarily suspend the operation of Section 1.2.1.4 of Tax Ordinace No. 1 s. 1976, otherwise known as the "Ormoc City Revenue Code of 1977", fixing the first twenty (20) days of January to pay tax obligations to the government, to provide not penly the members of the aforementioned retailers association, but all taxpayers with ample time to meet the various requirements relative tax obligations;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, severally seconded by mga Kagawad Eufrocino C. Codylla, Jr., Gregorio A. Yrastorza, Jr., Jose B. Conejos and Antero T.
