RESOLUTION NO. 07

A RESOLUTION EARNESTLY AND URGENTLY REQUESTING THE PHILIPPINE PORTS AUTHORITY, (PPA - CEBU), TO OPEN THE GATE LOCATED AT PIER 4, TO ALLOW THE PASSAGE OF PUBLIC AND PRIVATE UTILITY VEHICLES.

WHEREAS, a good number of businessmen and commuters from Ormoc. from the different places in Leyte and from neighboring Samar province, (the latter commuters who are used to pass by and board the ships from Ormoc bound to Cebu City and vice versa), have, in many occasions, complained in mass relative the closure by the PPA - Cebu of the Gate located at Pier 4, Cebu Port Area, Cebu City;

the closure of said gate hag caused a lot of inconveniences to the commuters, especially those from Cebu to Ormoc, more so during rainy days, for public and private utility vehicles are refused to pass through it, forcing these commuters to walk by themselves, carrying with them their heavy luggages, to a distance of more or less 150 meters to where the ferryboats are docked for them to be accommodated of their travels;

WHEREAS, the Aboitiz Shipping Company of which most of their ships are docked at Pier 4, seems helpless to this long existing condition. for, as alleged, it has never lifted a finger on requesting PPA - Cebu to have said gate open to utility vehicles;

THEREFORE, on motion of Kagawad Arnulfo C. Salazar, jointly seconded by mga Kagawad Benjamin F. Tugonon and Nelson L. Geneston; be
