A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR OF ORMOC TO WITHDRAW PUNDS AMOUNTING TO P420,000.00 FROM THE SPECIAL DEVELOPMENT ACCOUNT (SDA) ON DEPOSIT WITH THE PROVINCIAL DEVELOPMENT ASSISTANCE PROJECT / DEPARTMENT OF LOCAL GOVERNMENT (PDAP/DLG) FOR THE PURCHASE OF ONE (1) UNIT - EQUIPMENT "BACKHOE", FOR BARANGAY ROAD MAINTENANCE AND, LIKEWISE, TO SIGN WITHDRAWAL AGREEMENT TO THIS EFFECT, IN BEHALF OF THE CITY GOVERNMENT, WITH THE DLG.

WHEREAS, this august Body is in receipt of a communication from Her Honor, the City Mayor, addressed through the Honorable Chairman, Committee on Infrastructure, which letter is quoted hereunder, thus:

This is to formally request the honorable august Body for a resolution authorizing the undersigned to withdraw from our Special Development Account (SDA) funds now held by the Department of Local Government.

The amount of P420,000.00 will be utilized to purchase one (1) unit BACKHOE, which shall be used for barangay orad maintenance. Specially, the equipment will be utilized for digging canals along barangay roads.

Likewise the undersigned would like to request for authority to sign in behalf of the city government the covering withdrawal agreement between the DLG and the city.

Considering the need of this equipment, the passage of the resolution requested is earnestly sought.
