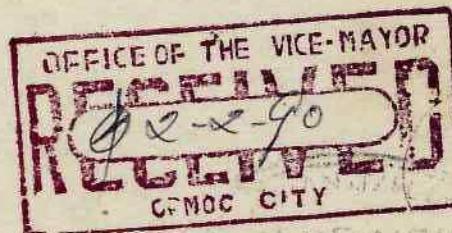
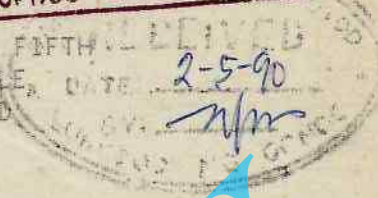

A RESOLUTION CONCURRENCE THE MAYOR'S PERMITS GRANTED EACH TO THE COCKPIT MANAGER OF VALENCIA SPORTS CENTER AT BRGY. VALENCIA, THE COCKPIT OWNER-OPERATOR OF NADONGHOLAN COCKPIT AT NADONGHOLAN, AND THE COCKPIT OPERATOR OF MACABUG COCKPIT AT BRGY. MACABUG, ALL IN ORMOC CITY, FOR THE PURPOSE OF RENEWING THEIR CORRESPONDING ANNUAL REGISTRATIONS OF BUSINESS FOR YEAR 1990 AT THE PHILIPPINE GAMEFOWL COMMISSION, TACLOBAN CITY.

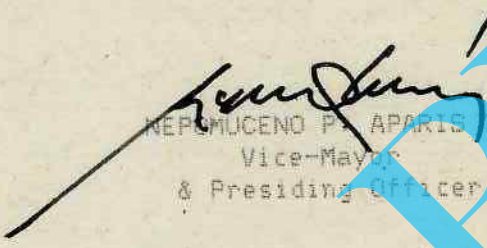

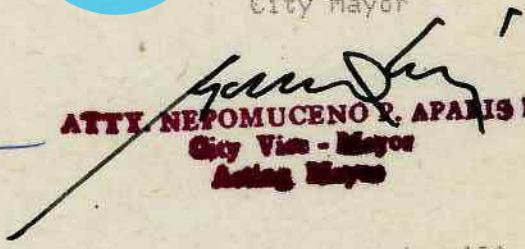
