RESOLUTION NO. 102

A RESOLUTION REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR, REGION VIII, TACLOBAN CITY, TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC TO UTILIZE THE AMOUNT OF P40,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND (EDF), TO BE MADE AVAILABLE TO DEFRAY FOR THE EXPENSES INCURRED BY THE ORMOC CITY DELEGATION TO TACLOBAN CITY ON THE OCCASION OF THE PRESIDENTIAL VISIT TO LEYTE, AUGUST 11, 1990, IN TACLOBAN CITY.

WHEREAS, Her Honor, the City Mayor, has urgently requested through a letter dated August 6, 1990 the Honorable Sangguniang Panlungsod ng Ormoc for an appropriation in the amount of P40,000.00 to be made available to defray for the expenses to be incurred by the Ormoc City delegation to Tacloban City on the occasion of Her Excellency's Official Visit to Leyte in Tacloban City on August 11, 1990;

WHEREAS, the aforementioned letter of the Honorable City Mayor has further alleged that "preparations are being made for 250 employees of the city government and 110 barangay chairmen to welcome President Corazon C. Aquino to Leyte. The expenses which includes bus rentals, streamers and packed lunches, are estimated to total P40,000.00";

WHEREAS, the City Budget Officer through her 3rd Indorsement dated August 22, 1990, has recommended that the financial requirement of the subject appropriation of P40,000.00 to defray for the expenses incurred by the Ormoc City delegation to Tacloban City during the said Presidential visit on August 11, 1990 be funded from the 20% Economic Development Fund;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, has enacted RESolution No. 101 embodying Appropriation Ordinance No. 90-36, (a copy of same is hereto attached), approving in PRINCIPLE of an appropriation of FORTY THOUSAND PESOS,

(P40,000.00), from out of the 20% Economic Development Fund (EDF), said amount or so much thereof to be made available to defray the expenses incurred by the Ormoc City delegation to Tacloban City on the occasion of the Presidential visit, August 11, 1990, in Tacloban City, subject, however, to a passage of resolution requesting the Department of Local Government for an authorization relative its utilization;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, jointly seconded by mga Kagawad Gregorio A. Yrastorza, Jr. and Celso P. Porcadilla; be it


RESOLVED, to pass a resolution EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL THROUGH ITS REGIONAL DIRECTOR RESURRECCION S. SALVATIERRA, REGION VIII, TACLOBAN CITY, TO AUTHORIZE THE HONORABLE CITY MAYOR TO UTILIZE THE AMOUNT OF P40,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND (EDF), the same amount to be made available to defray the expenses incurred by the Ormoc City delegation to Tacloban City August 11, 1990 on the occasion of the Presidential Visit to said place;

ENACTED, August 23, 1990.

RESOLVED, FURTHER, to furnish copies of this resolution each to the Department of Local Government through Director Resurreccion S. Salvatierra, Regional Director, DLG, Tacloban City; Honorable Ma. Victoria L. Locsin, City Mayor, Ormoc City; the City Treasurer and the City Budget Officer, - both in Ormoc City;
