Local Government Code;

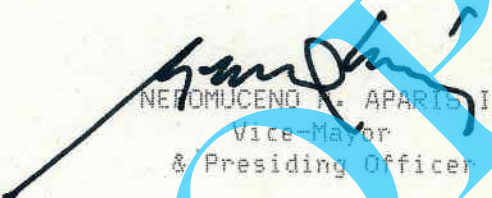

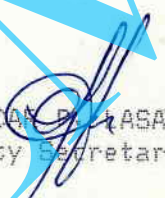
