RESOLUTION NO. 105

A RESOLUTION FAVORABLY ENDORSING RESOLUTION NO. 741 S. 1990 OF THE SANGGUNIANG PANLUNGSOD NG DAVAO RE PASSAGE OF A RESOLUTION REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT AND THE JOINT COMMISSION ON LOCAL GOVERNMENT PERSONNEL ADMINISTRATION TO GRANT ALL LOCAL GOVERNMENT UNITS WITH THE PRIVILEGES (PER DIEMS AND ALLOWANCES) GRANTED UNDER THE NATIONAL BUDGET CIRCULAR NO. 391 S. 1987.

WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of Resolution No. 741 s. 1990 of the Sangguniang Panlungsod ng Davao re Passage of a Resolution requesting the DLG and the JCLGPA to grant all local government units with the privileges (per diems and allowances) granted under the National Budget Circular No. 391, dated October 6, 1987, previously allowed only to government-owned and/or controlled corporations under Executive Order No. 151, dated March 19, 1987;

WHEREAS, this august Body believes reasonable that with the aforementioned privileges granted to local government units would bolster the morale and enhance the efficiency of works of the local government personnel;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, severally seconded by mga Kagawad Gregorio A. Yrastorza, Jr., Arnulfo C. Salazar and Nelson DL. Geneston; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to favorably endorsed Resolution No. 741 s. 1990 of the Sangguniang Panlungsod ng Davao regarding the passage of a resolution requesting the Department of Local Government (DLG) and the Joint Commission on Local Government Personnel Administration (JCLGPA) to grant all local government units with the privileges (per diems and allowances) granted under the National Budget Circular No. 391 s. 1987;




