RESOLUTION NO. 106

A RESOLUTION FAVORABLY ENDORSING RESOLUTION NO. 844 S. 1990 OF THE SANGGUNIANG PANLUNGSOD NG DAVAO, URGING CONGRESS OF THE PHILIPPINES TO DESIST FROM PASSING MORE TAX MEASURES CONSIDERING THAT THE FILIPINO PEOPLE ARE ALREADY OVERBURDENED WITH ECONOMIC DIFFICULTIES.

WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of Resolution No. 844 s. 1990 of the Sangguniang Panlungsod ng Davao urging Congress to desist from passing more tax measures considering that our people are already overburdened with economic difficulties;

WHEREAS, this august Body conforms to the propriety and embodiment of the aforesaid resolution, for very true that when there are more tax measures passed by Congress, prices of prime commodities, transportation fares, cost of education, etcetera, will also increase and "the people will sink deeper into the quagmire of economic difficulties";

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, severally seconded by mga Kagawad Gregorio A. Yrastorza, Jr., Arnulfo C. Salazar and Nelson DL Geneston; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to favorably endorse Resolution No. 844 s. 1990 of the Sangguniang Panlungsod ng Davao, urging Congress of the Philippines to desist from passing tax measures considering that the Filipino people are already overburdened with economic difficulties;


