RESOLUTION NO. 107

A RESOLUTION EARNESTLY REQUESTING THE REGIONAL EXECUTIVE DIRECTOR, DENR, TACLOBAN CITY, TO CANCEL OR DISAPPROVE ALL APPLICATIONS ON LEASEHOLD OR FOR MISCELLANEOUS SALES FILED IN YOUR OFFICE BY ANY PERSON, FIRM OR CORPORATION OVER A PARCEL OF LAND CAD. LOT NO. 3632 OF THE CADASTRAL SURVEY OF ORMOC, AND ON THE ABANDONED PANILAHAN RIVERBED OR ANY PORTION THEREOF, ALL SITUATED AT BARANGAY MACABUG, ORMOC CITY, AS SAID AREAS ARE RESERVED BY THE CITY GOVERNMENT OF ORMOC, NOW USED AS DUMPING SITE OF THE CITY GARBAGE DISPOSAL.

WHEREAS, there are private individuals who have alleged that they have filed their claims before the Land Management Sector, DENR Regional Office, Tacloban City (formerly the Bureau of Lands - Region VIII), over Cad. Lot No. 3632 and the abandoned Panilahan riverbed or any portion thereof, all situated at Barangay Macabug, Ormoc City, without the knowledge and approval of the Ormoc City government;

WHEREAS, the City Government has made official requests for the disapproval or cancellation of said applications or claims, as evidenced by a letter dated August 19, 1976 of Atty. F. T. Capuyan, former City Legal Officer, addressed the Regional Director, Bureau of Lands, Region VIII, Tacloban City and, lately, through a letter dated August 9, 1990 of Mr. I. L. Cortes, Jr., Public Services Supervisor II, requesting the Honorable Sangguniang Panlungsod ng Ormoc, through the favorable indorsement of the Honorable City Mayor, again for the cancellation or disapproval of all applications or claims filed before the DENR Regional Office, Region VIII, Tacloban, over the aforementioned areas;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, has considered very logical to give due course and immediate action on the requests, particularly that of the Public

Service Supervisor II, this city, for the cancellation/disapproval of all claims filed over Lot No. 3632 and the abandoned Panilahan riverbed, for the said premises are reserved and now utilized by the City Government as areas for garbage dumping purposes;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, Chairman, Committee on Public Properties, jointly seconded by mga Kagawad Celso P. Adolfo and Nelson DL. Geneston; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to, earnestly request the Regional Executive Director, Department of Environment & Natural Resources, Region VIII, Tacloban City, to cancel or disapprove all applications for leasehold and miscellaneous sales filed before said Regional Office by any person, firm or corporation over a parcel of land Cad. Lot No. 3632 of the Cadastral Survey of Ormoc, and the abandoned Panilahan riverbed or any portion thereof, all situated at Barangay Macabug, Ormoc City, as said areas are reserved by the City Government of Ormoc and, now used as Dumping Site of the City garbage disposal;
