RESOLUTION NO. 11

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE THE TOTAL AMOUNT OF P47,860.06, (GENERAL FUND - P28,742.08, INFRASTRUCTURE FUND - P19,117.98), REPRESENTING PAYMENTS OF DIFFERENTIAL CLAIMS FOR SEPARATION BENEFITS OF EMPLOYEES CONCERNED UNDER REPUBLIC ACT NO. 6683, AGAINST THE CURRENT APPROPRIATIONS FOR OUTLAY OF LEAVE CREDITS IN DIFFERENT CITY GOVERNMENT OFFICES CONCERNED.

WHEREAS, Her Honor, the City Mayor, has endorsed to the Honorable Sangguniang Panlungsod ng Ormoc for appropriate action a money claim of Ms. Rudith E. Balugo, former DLG-detailed employee, for separation benefits under RA 6683, including other employees with similar claims as cited hereunder, with their corresponding computations of benefits under said RA 6683, to wit:

WHEREAS, Assistant Director B.V. Valle, Civil Service Commission, Region 8, Tacloban City, in his authoritative letter dated April 21, 1989, he has stated that, "RA 6683 has been legislated to provide for the early retirement and voluntary separation from the service, AS WELL AS involuntary separation of civil service officers and employees as a result of various Executive Orders authorizing government reorganization after the ratification of the 1987 Constitution.

"X X X provision No. 2.2 of the Joint DBM-CSC Circular Letter No. 88-1 dated December 12, 1988, defines clearly those covered under the so-called involuntary separation. Whereas, provision No. 3.1 of Joint DBM-CSC Circular Letter No. 89-1 dated January 31, 1989, refers to those who may avail of the grant under the voluntary mode of separation. In fine, the former refers to those who were phased out as a result of the reorganization X X X, whereas the latter, refers to those who on December 2, 1988 are still in the service for at least two years, either as casual, emergency, temporary or regular appointment status and who opt to retire therefrom."

WHEREAS, the City Budget Officer has recommended that the City Treasurer, (with the latter's signed conformity as to the charges), be granted with authority to charge the total amount of P47,860.06, representing payments of differential claims for separation benefits under RA 6683 of the aforementioned employees, against the current appropriations for Outlay for Leave Credits in different Offices, as follows:

1. To their respective offices
 - a) City Treasurer's Office
 - b) City Legal Office
 - c) City Health Office
2. To City Treasurer's Office, for offices without appropriation or with deficiency in appropriation
 - a) City Population Office
 - b) City Development Office
 - c) City Legal Office


