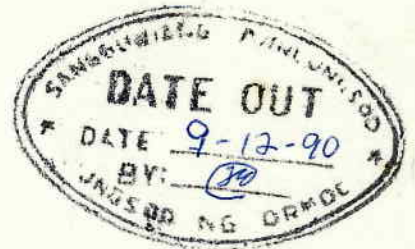

RESOLUTION NO. 110

A RESOLUTION REQUESTING THE STATION COMMANDER OF THE ORMOC-INP TO
CONDUCT ROUTINARY INSPECTIONS ON ILLEGAL GAMBLINGS, (ILLEGAL
COCKFIGHTINGS, "HANTAK", ETCETERA,), AND/OR STOP THESE ILLEGAL
GAMBLING ACTIVITIES.

WHEREAS, Ormoc City has been dubbed "the most peaceful city" in the
Province of Leyte, if not in whole of Region VIII for a number of years;

WHEREAS, nowadays, however, Ormoc City is not spared with the
existence of illegal gambling activities, like illegal cockfightings,
"hantak", and so forth, which have marred for somehow the peacefulness
of the place, for usually the victims of these vicious and pernicious
forms of gambling would wittingly succumb to the commission of crimes
against persons and properties, like swindling, robbery, theft, to
further extent - murder (to mention a few) principally for the reason of
generating funds;

WHEREAS, these forms of illegal gamblings which have proliferated
Ormoc City for quite a time, have eroded slowly but surely the people's
morality, for gambling affects much on the people's behavior and morale;

WHEREAS, this august Body, in its earnest and sincere efforts and
desire to curb down gamblings, must provide due course and immediate
action against, in order to protect and defend the people's general
welfare;

NOW, THEREFORE, on motion of Kagawad Eufrocino C. Codilla, Jr.,
duly seconded by Kagawad Jose B. Conejos; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to request the Station Commander of the Ormoc INP to conduct routinary inspections on illegal gamblings, (illegal cockfightings, "hantak", etcetera,), and/or stop these illegal gambling activities;
