A RESOLUTION RECOMMENDING APPROVAL OF THE SPECIAL FARE RATES FOR MOTORIZED TRICYCLES (MCH) OPERATING WITHIN ORMOC CITY AND SUBURBS. AS REQUESTED BY OLALMODA PRESIDENT, BASED ON AN ORDER OF THE LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD, DTC, TACLOBAN CITY.

WHEREAS, the Honorable Sangguniang Panlungsod ng Ormoc is in receipt of a letter dated September 12, 1990 from the Ormoc Libertad Airport Liloan Margen Motorized Tricycles Operators and Driver's Association, Inc., (OLALMODA), through its OLALMODA President, requesting the City Board for passage of a resolution recommending for approval of their requested Special Fare Rates for Motorized Tricycles (MCH) within Ormoc City and Suburbs, based on an Order of the Land Transportation Franchising and Regulatory Board, Department of Transportation and Communication - Regional Office, Tacloban City, which Order of the LTFRB is hereunder reflected as follows:

"At least TEN (10) days prior to the date, applicant shall publish this Notice once in one (1) daily newspaper of general circulation in the Visayas, and serve by personal delivery or registered mail copy of the application and this Notice to all affected parties.

"Parties opposed to the granting of the application must file their written oppositions supported by documentary evidence on or before the above dated furnishing a copy of the same to the applicant, and may, if they so desire, appear on said date and time.

"This application shall be acted upon by the Board on the basis of its record and the documentary evidences submitted by parties unless the Baord deems it necessary to receive additional documentary and/or oral evidence.
