RESOLUTION NO. 112

A RESOLUTION APPROVING RESOLUTION NO. 019 S. 1990 OF THE BARANGAY COUNCIL OF PUNTA, REQUESTING THE CITY GOVERNMENT FOR APPROVAL OF THE TEMPORARY USE OF A PORTION OF AN UNFINISHED CITY ROAD SITUATED IN SAID BARANGAY TO BE MADE A TEMPORARY VENUE FOR THEIR BARANGAY FIESTA '90 ACTIVITIES AND FUNCTIONS.

WHEREAS, the Sangguniang Panlungsod is in receipt of Resolution No. 019 s. 1990 of the Barangay Council of Punta, this city, requesting Her Honor, the City Mayor and the 5th Sangguniang Panlungsod ng Ormoc for approval of the temporary use of a portion of an unfinished city road, (shown in a sketch presented), situated in said barangay to be made as a temporary venue for the performance or presentation of the different activities and functions in connection with said barangay's forthcoming Fiesta celebration on December 3, 1990;

WHEREAS, the same resolution has further alleged that the choice of road location cannot create traffic congestions as said unfinished road is seldom used, besides, the place is believed most accessible for all the barangay constituents;

WHEREAS, the Honorable Chairman, Committee on Laws and Ordinances, with the indorsement of the Honorable Chairman, Committee on Public Properties, has recommended approval of the subject request "provided that the city has no need of said road as of the moment and with the condition that the same will be used for the duration of the celebration of the Barangay Fiesta only";

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, Chairman, Committee on Public Properties, jointly seconded by mga Kagawad Benjamin F. Tugonon and Celso P. Porcadilla; be it


