RESOLUTION NO. 113

A RESOLUTION EARNESTLY REQUESTING THE ENERGY REGULATORY BOARD, MANILA, TO STOP THE CHARGING OF POSTED PRICE DIFFERENTIALS OF GASOLINE/OTHER MOTOR FUELS AND LIQUIFIED PETROLEUM GAS (LPG) ON CONSUMERS' PRICES.

WHEREAS, the cost or market price of gasoline and other motor fuels and of the liquified petroleum gas (LPG) in Ormoc City is much higher than in Tacloban City;

WHEREAS, the principal cause of the variance of prices of these commodities in said cities is the continued charging on Consumers' Prices in Ormoc City of the burdensome Posted Price Differentials, allegedly for the recovery of the cost of a construction of a bulk plant or depot at Barangay Linao, Ormoc City;

WHEREAS, this practice of charging on the Consumers' Prices of these Posted Price Differentials at P0.062 per liter for motor fuels and 0.46 per kilogram or P5.06 per 11 kilograms of LPG has been exercised for seven (7) years, from the completion of the construction of the subject depot in 1983 up to now, so that the span of time is believed more than sufficient for PETROPHIL Corporation to have recovered the cost incurred for the said construction;

WHEREAS, the stoppage on charging this onerous Posted Price Differentials on the Prices for Consumers is justifiable and would prove beneficial to the buying public or the people, for they could buy now the subject commodities at just or reasonable prices;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., Vice Chairman, Committee on Energy Development and Conservation, jointly seconded by mga Kagawad Celso P. Adolfo and Eufrocino C. Codilla, Jr., be it


