RESOLUTION NO. 114

A RESOLUTION APPROVING RESOLUTIONS NOS. 2, 2-A AND 4, ALL SERIES OF 1990, EMBODYING ORDINANCES NOS. 1, 3 AND 4, RESPECTIVELY, OF THE BARANGAY COUNCIL OF MATICA-A, ORMOC CITY.

WHEREAS, the Honorable Sangguniang Panlungsod is in receipt of Resolutions Nos. 2, 2-A and 4, all Series of 1970, from the Barangay Council of Matica-a, Ormoc City;

WHEREAS, said Resolutions Nos. 2, 2-A and 4 are the embodying resolutions of Ordinances Nos. 1, 3 and 4, respectively, of the said Council, with the captions or titles of said ordinances being stated correspondingly hereunder as follows:

ORDINANCE NO. 1 - AN ORDINANCE PROHIBITING ALL OWNERS AND CARETAKERS OF ALL DESTRUCTIVE ANIMALS AND FOWLS, NOT TO LET THEIR ANIMALS GO ASTRAY WITHIN THE BARANGAY AND IN THE BARANGAY OUTSKIRTS, FOR THE ENTIRE DAY AND NIGHT TIME.

ORDINANCE NO. 3 — AN ORDINANCE REQUIRING ALL THE RESIDENTS
OF BARANGAY MATICA—A TO CULTIVATE A VEGETABLE GARDEN IN
THEIR BACKYARD OR ON ANY ADJACENT VACANT LOTS NEAR
THEIR HOMES FOR ECONOMIC PURPOSES AND TO PROMOTE BETTER
HEALTH CONDITIONS AMONG THE RESIDENTS OF THE BARANGAY.

ORDINANCE NO. 4 - AN ORDINANCE PROHIBITING ALL RESIDENTS OF THE BARANGAY, INCLUDING MINORS, FROM GETTING PLANTS, FRUITS, ROOTCROPS, ETCETERA, WITHIN THE SCHOOL PREMISES AND THE WHOLE COMMUNITY, WITHOUT ASKING PERMISSION FROM THE OWNER/CARETAKER OF SAID PLANTS.
