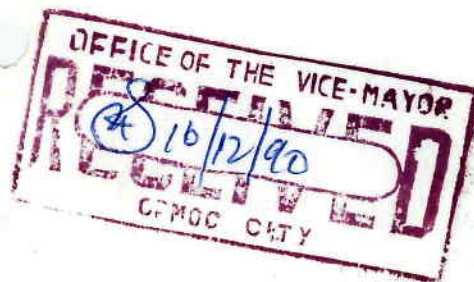

RESOLUTION NO. 122

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A DEED OF ABSOLUTE SALE WITH TELESFORO ESMERO, JACINTA E. VDA DE CAMAQUIN, GLORIA ESMERO AND GERONIMA ESMERO PALACIO, LOT OWNERS OF LOTS NOS. 5362-D, 5362-C, 5362-B AND 5362-A, RESPECTIVELY, SAID LANDS BEING LOCATED AT BRGY. SAN ISIDRO, THIS CITY, IN CONNECTION WITH RESOLUTION NO. 120 EMBODYING APPROPRIATION ORDINANCE NO. 90-42 (ITEM B) ENACTED OCTOBER 4, 1990.

WHEREAS, this august Body has enacted Resolution No. 120 s. 1990 embodying Appropriation Ordinance No. 90-42 (Item B) authorizing payments in the total amount of Two Million Four Thousand Five Hundred Fifty Pesos, (P2,004,550.00), to Lot Owners Telesforo Esmero, Jacinta E. Vda de Camaquin, Gloria Esmero and Geronima Esmero Palacio, of Lots Nos. 5362-D, 5362-C, 5362-B and 5362-A, respectively, said lands all situated at Brgy. San Isidro, Ormoc City, with corresponding Transfer Certificates of Titles (TCT) Nos. 13645 (part), 13544, 13643 and 13642, with Areas 7,548 sq.m., 10,848 sq.m., 10,848 sq.m. and 10,847 sq.m., respectively, for said lands are intended to be used in connection with the Housing Project for the city government employees, as programmed by the City Government;
