RESOLUTION NO. 124

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR OF ORMOC TO SIGN,
FOR AND IN BEHALF OF THE CITY GOVERNMENT, AN AMENDED CONTRACT WITH
THE FAR EAST CORPORATION FOR THE PREPARATION OF DESIGN, PLANS AND
ESTIMATES AS WELL AS CONSTRUCTION SUPERVISION SERVICES OF THE
PROPOSED MULTI-PURPOSE GYMNASIUM IN ORMOC CITY.

WHEREAS, a letter dated October 10, 1990 from the Honorable City
Mayor, addressed the Honorable Sangguniang Panlungsod, requesting for
passage of a resolution authorizing Her Honor to enter into an amended
agreement with Far East Corporation relative to the construction of the
Multi-Purpose Gymnasium in Ormoc City, the full text of said letter is
hereunder cited as follows:

Gentlemen:

Anent to our deliberations with representatives of Far
East Corporation regarding certain amendments to our contract
with that firm, it is respectfully requested that a
resolution be passed authorizing the undersigned to enter
into an agreement for the following amendments of that
contract viz:

(RES. NO. 124 S. 1990)

1. Fee for the preparation of plans, designs and estimates shall be fixed at 3.5% of the total cost of the preliminary submittal amounting to P38,168,596.90 (Total fee is P1,335,900.86)
2. Fee for the construction supervision shall be at .3% of the total bidded cost of the project.
