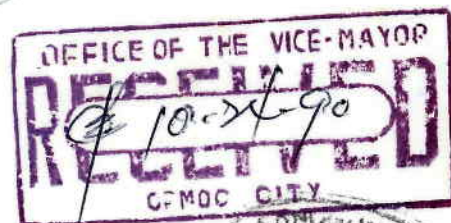

RESOLUTION NO. 127

A RESOLUTION APPROVING RESOLUTION NO. 3 S. 1990 EMBODYING ORDINANCE NO. 2 OF THE BARANGAY COUNCIL OF CAN-ADIENG, ORMOC CITY, APPROPRIATING THE AMOUNT OF ONE HUNDRED PESOS (P100.00) PER MONTH RENTAL OF THE BARANGAY HALL, WHICH FUNDS TO BE TAKEN FROM THE BARANGAY ADMINISTRATION FUND AND FROM THE 10% SHARE OF REAL ESTATE TAXES COLLECTED AND PRESENTLY DEPOSITED WITH THE CITY TREASURER'S OFFICE.

WHEREAS, this august Body is in receipt of Resolution No. 3 s. 1990 embodying Ordinance No. 2 of the Barangay Council of Can-adieng, appropriating the amount of One Hundred Pesos (P100.00) per month for the rental of a house/room owned Ms. Adelaida Salazar of Barangay Can-adieng, this city, to be utilized as Barangay Hall, the amount to be made available be taken from out of the Barangay Administration Fund and from the 10% share of Real Estate taxes collected and presently deposited with the City Treasurer's Office as Trust Fund;

WHEREAS, this august Body conforms to the propriety of the aforesaid resolution-ordinance, for it ultimately works out, among others, for the interest of public service;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, Chairman, Committee on Laws and Ordinances, duly seconded by Kagawad Edgar Z. Palugod; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to approve Resolution No. 3 s. 1990 embodying Ordinance No. 2 of the Barangay Council of Can-adieng, Ormoc City, re appropriating the amount of One Hundred Pesos (P100.00) per month rental of the Barangay Hall and, the amount to be made available for the purpose be taken from the Barangay Administration Fund and from the 10% share of Real Estate taxes collected and presently deposited with the City Treasurer's Office as Trust Fund;
