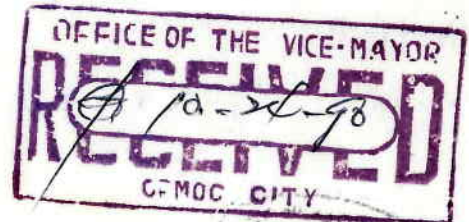

RESOLUTION NO. 131

A RESOLUTION APPROVING THE REQUEST OF THE BARANGAY COUNCIL OF CABULIHAN, ORMOC CITY, ON CHARGING THE 1989 ACCOUNT OF SAID BARANGAY IN THE AMOUNT OF P214.50 INCURRED IN 1989 IN THE PURCHASE OF MATERIALS FOR THE CONSTRUCTION OF ITS BARANGAY HALL, TO THE CURRENT APPROPRIATION OF SAID BARANGAY.

WHEREAS, the Honorable Sangguniang Panlungsod ng Ormoc is in receipt of an Unnumbered Resolution s. 1990 of the Barangay Council of Cabulihan, this city, Re requesting the 5th Sangguniang Panlungsod ng Ormoc to charge the 1989 Account of Barangay Cabulihan in the amount of P214.50 to the Current Appropriation of the barangay;

WHEREAS, said unnumbered resolution has further alleged the following:

- a) that the amount of P214.50 was incurred in 1989 in the purchase of materials used in the construction of its barangay hall,
- b) that said account was not paid in year 1989 for the papers covering the account was misplaced, only to be found lately,
- c) and, said account could no longer be paid unless the same shall be charged to the current appropriation for failure to have said account obligated for payment in the 1989 budget.

WHEREAS, this august Body believes that the request of the Barangay Council of Cabulihan is very reasonable, hence, must be accorded with due course and immediate action;

RESOLVED, AS IT IS HEREBY RESOLVED, to approve the request of the Barangay Council of Cabulihan, this city, on charging the 1989 Account of said barangay in the amount of P214.50 incurred in 1989 in the purchase of materials for the construction of its barangay hall, to the Current Appropriation of said barangay;

ENACTED, October 18, 1990.
