RESOLUTION NO. 133

A RESOLUTION APPROVING RESOLUTION NO. 10 S. 1990 EMBODYING ORDINANCE NO. 10 OF THE BARANGAY COUNCIL OF DON POTENCIANO LARRAZABAL, APPROPRIATING THE AMOUNT OF THIRTY PESOS (P30.00) MONTHLY RENTAL OF A TYPEWRITER, WHICH FUNDS TO BE TAKEN FROM THE 10% SHARE OF REAL ESTATE TAXES COLLECTED AND PRESENTLY DEPOSITED WITH\$ THE CITY TREASURER'S OFFICE AS TRUST FUND.

WHEREAS, this august Body is in receipt of Resolution No. 10 s. 1990 adopting Ordinance No. 10 of the Barangay Council of Brgy. Don Potenciano Larrazabal, appropriating the amount of Thirty Pesos (P30.00) per month for the rental of a typewriter for official use of the Barangay Officials of Don Potenciano Larrazabal, the amount to be made available be taken from the 10% share of Real Estate taxes collected and presently deposited with the City Treasurer's Office as Trust Fund;

WHEREAS, said resolution has further alleged the following:

- that Barangay Don Potenciano Larrazabal has no typewriter for officila use - making reports and communications of the Council;
- b) the barangay budget for year 1990 has no entry for the purchase of a typewriter;
- c) the Barangay Council is presently renting a typewriter to serve the needs of the Council.
