## RESOLUTION NO. 136

A RESOLUTION HIGHLY REQUESTING HER EXCELLENCY, PRESIDENT CORAZON C. AQUINO, THROUGH THE PRESIDENTIAL MANAGEMENT STAFF, FOR ASSISTANCE ACQUISITION OF FIVE (5) DUMP TRUCKS AND TWO (2) IN THE TRUCKS FOR ORMOC CITY.

WHEREAS, the Honorable Sangguniang Panlungsod ng Ormoc is in receipt of a letter dated 11 October 1990 from Atty. M. B. Gaite, Presidential Staff Director, Presidential Management Staff, Malacanang, Manila, addressed Her Honor, the City Mayor of Ormoc, informing the latter relative her request for five (5) dump trucks and two (2) garbage trucks for Ormoc City:

WHEREAS, the said letter has further alleged that "evaluation of requests for dump and garbage trucks is being undertaken by a technical group X X , considering the following criteria:

- present population and population growth rate
- total daily garbage generation
- capability to maintain and operate, and
- availability of technical manpower and spare parts in the locality

And, that, , LGUs' requests could be facilitated accompanied by X X X council resolution indicating the justifications based on the above mentioned criteria";

WHEREAS, the Honorable Chairman, Committee on Infrastructure, has endorsed the aforecited letter to the City Planning and Development Coordinator for comments and evaluation to justify the city's request to acquire the subject dump trucks and garbage trucks;

WHEREAS, the City Planning and Development Coordinator, in his 4th Indorsement dated 18 October 1990, has submitted the following data needed in the city's request for 5 dump trucks and 2 garbage trucks, as follow:

- 1) Present population = 144,530 (1990) Population growth rate= 2.1%
- 2) Total Daily garbage
   qeneration = 11 cu.m.
- 3) The City is capable to maintain and operate the additional units (5 dump trucks and 2 garbage trucks)
- 4) The City has available technical manpower in the Office of the City Engineer. Spare parts are also available in the locality or in Cebu City or Tacloban City.

WHEREAS, this august Body fully believes that the subject request for dump and garbage trucks is very important to augment the aging and inadequate fleet of trucks of the city, and very necessary to enhance capability to maintain, improve and repair barangay to market roads and to solve garbage disposal problem;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., Chairman, Committee on Infrastructure, severally seconded by mga Kagawad Eufrocino C. Codilla, Jr., Arnulfo C. Salazar and Antero T. Fiel; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to highly request Her Excellency, President Corazon C. Aquino, through the Presidential Management Staff, for assistance in the acquisition of five (5) dump trucks and two (2) garbage trucks to augment the aging and inadequate fleet of trucks - for maintenance, improvement and repairs of barangays roads and for garbage disposal purposes in Ormoc City;

Locsin, City Mayor, and the City Flanning and Development Coordinator, — both in Ormoc City;
