RESOLUTION NO. 138

A RESOLUTION MOST RESPECTFULLY REQUESTING HER EXCELLENCY, CORAZON C. AQUINO TO GRANT THE CITY GOVERNMENT OF EXEMPTION FROM THE PROVISION OF ADMINISTRATIVE ORDER NO. TO ALLOW RENEWAL OF CONTRACT WITH ATTY. EVERGISTO S. ESCALON AS CITY LEGAL OFFICER.

WHEREAS, this august Body is in receipt of a letter from Her Honor, City Mayor dated 22 October 1990, the full text of said letter is hereunder cited as follows:

Gentlemen:

Our contract with Atty. Evergisto S. Escalon expires on November 30, 1990. Considering the continuing need of our City for his services, it is necessary that his contract is renewed.

However, Administrative Order No. 177 provides among others, the discontinuance of the hiring of all contractuals. This necessarily affects our intention to renew the contract of Atty. Escalon.

In veiw thereof, it is respectfully requested that a resolution be passed, requesting Honorable President Corazon C. Aquino to grant the City Government an exemption from this particular provision of Administrative Order No. 177 and allow us to renew our contract with Atty. Evergisto 5. Escalon.

WHEREAS, previously, the City Government of Ormoc has its City Legal Officer, however, which position was subsequently abolished due to forced retirement of the incumbent and, the Joint Commission on Local Government Personnel Administration (JCLGPA) has stated that " X X X an abolished position cannot be re-created within two (2) years from its abolition. Be that as it may, it is suggested that in lieu of a reclassification action, the City Government in the meantime may create a contractual position of Legal Counsel whose rate shall not exceed the salary of a city department head due to the exigency of the service";

WHEREAS, the Office of a City Legal Officer is a vital Office for a city, a corporate entity and a must to have a City Legal Officer as its legal arm on legal matters and cases for or against the same;

WHEREAS, Atty. E. S. Escalon has proven himself reasonable and competent to the tasks and responsibilities inherent to the position as City Legal Officer during his first year of contract with the City Government of Ormod:

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, jointly seconded by mga Kagawad Nelson DL. Geneston and Edgar Z. Palugod; be it

RESOLVED, to pass a resolution MOST RESPECTFULLY REQUESTING HER EXCELLENCY, PRESIDENT CORAZON C. AQUINO TO GRANT THE CITY GOVERNMENT OF ORMOC AN EXEMPTION FROM THE PROVISION OF ADMINISTRATIVE ORDER NO. 177 SO AS TO ALLOW RENEWAL OF CONTRACT WITH ATTY. EVERGISTO S. ESCALON AS CITY LEGAL OFFICER;
